EMERGENCY DEMAND FOR EMERGENCY HABEAS CORPUS JURY TRIAL

This Emergency Demand for Emergency Habeas Corpus Jury Trial filed Oct. 19, 2021.

I. THIS MASSACRE/ UNHOLY BLOOD WAR HAS A SPECIAL PLACE IN HISTORY

1. The attached Habeas Corpus was filed on September 10, 2021 demanding rescue from the massacre of parents and children in a Murder for Hire ¹Enterprise perpetrated by judicial criminals under the auspices of the government by falsely tagging it with the moniker/misnomer “guardianship” (the “Guardian Murder for Hire Enterprise”).
2. The false moniker is tantamount to tagging Nazi Death Camps “Gyms” to profess therapy.

3. The Murder for Hire Enterprise is built on the insurmountably false premise that government operatives can steal the birth rights of the People. See Article III.
4. Some of the many lawless acts that took place upon the Habeas Corpus filing to circumvent and obstruct relief from the Guardian Murder for Hire Enterprise and cover up include:
 - a. Threats, extortion ²and blackmail ³against the Complainants to prohibit them from seeking involvement by a judicial government employee;
 - b. Thus use of a non-judge clerk Kristin to act as an imposter judge
 - c. Non-orders by non-judge Kristine acting as an imposter judge for Claimants to file the Habeas Corpus with government employees Ron Desantis (“Ron”) and Ashley Moody (“Ashley”) when:
 - Kristina had already furnished Ron and Ashley a copy;
 - Ron and Ashley falsely deny they run the Guardian Murder for Hire Enterprise
 - d. The illegal obstruction by “redirect” to another judicial government employee court in violation of the Constitution.⁴
 - e. “Secret code signals” by **Kristina Samuels, Florida Bar #26958** and her non-judge lower petty “redirected” court counterpart, also acting as an imposter judge to obstruct.
5. Predictably such obstruction, circumvention, threats, conspiracy, conflict of interest and cover up activities occurred.
6. Disqualified, jurisdiction-less judicial employee, Layne Smith who was appointed by Ron and thereby acts in conflict of interest, immoral, ethical breach and violation of judicial canons deprived Complainants of their access to that “redirected” court.
7. Thus, we have re-filed herein.
8. It is perverse that we are embroiled in this recycled crime.
9. The judicial government employees herein should be horrified and offended by the stench.

II. # WE KNOW

10. #We Know and make clear the obvious:
 - a. Although it is made to appear that the judicial government branch is responsible for the Guardian Murder for Hire Enterprise, it is the responsibility of Ron⁵ and Ashley⁶ who are violating the Sovereign laws of the Creator and the founding documents.

- b. Although judicial criminals delusionally pretend and operate the Guardian Murder for Hire Enterprise as a “normal” litigation against an adversary, they do so to deflect and divert from the incontrovertible fact that they have **no jurisdiction** to:

 - Adjudicate their own crimes;
 - Weaponize the law against their victim to avoid accountability.
- c. IV. PURPOSE OF GOVERNMENT INCLUDING JUDICIAL EMPLOYEES

19. Governments` are installed to **Protect** rights.¹¹
20. Habeas Corpus is mandatory by this Court. ¹²
21. Independent impartial adjudication by Jury Trial is mandated.
22. Universal U.N. International Remedy and Reparation Conventions are incorporated herein.
23. Governments are obliged to:
 - a. carry out exhaustive and impartial investigations into allegations of human rights violations and atrocities;
 - b. bring to justice and punish their perpetrators,
 - c. to grant compensation to the victims or their families, and
 - d. to take effective measures to avoid future recurrence of such violations.

A. INDEPENDENT AND IMPARTIAL INVESTIGATION

24. By international law, States must establish functioning courts of law or other tribunals presided over **by independent, impartial and competent individuals** as a prerequisite to ensuring that victims have access to an effective remedy.
25. The investigators, who shall be independent of the suspected perpetrators and the agency they serve, shall be competent and impartial.
26. They shall have access to, or be empowered to commission investigations by, impartial medical or other experts.
27. The methods used to carry out such investigations shall meet the highest professional standards and the findings shall be made public.
28. Equally necessary is the existence of competent authorities to enforce the law and remedies.

B. DUTIES OF STATES ARISING FROM HUMAN RIGHTS

29. Under U.N. Conventions, the duty of the State to ensure human rights has several consequences that are relevant for victims of gross human rights violations:
 - a. The State has to adopt all necessary legislative and other measures, and to organize its entire governmental apparatus in a manner that will enable it to comply with all its human rights obligations.
 - b. Moreover, it has the duty to provide effective remedies against human rights violations; to investigate and reveal the truth about human rights violations; to bring perpetrators of gross human rights violations to justice; and to provide reparation to victims.

c. Victims of gross human rights violations have a right to truth; justice; and reparation. These State obligations invoke the need to provide effective remedies against human rights violations; to investigate and reveal the truth about human rights violations; to bring perpetrators of gross human rights violations to justice; and to provide reparation to victims are corollaries to the rights to truth, to justice and to reparation.

30. The Declaration on Protection of All Persons from Enforced Disappearance,¹³ UN Principles on Extra-legal Executions,¹⁴ and UN Principles on the Investigation of Torture¹⁵ require that those potentially implicated in the violations shall be removed from any position of control or power, whether direct or indirect over complainants, witnesses and their families, as well as over those conducting investigations.

C. IMPARTIAL, FAIR AND INDEPENDENT PUBLIC GRAND JURY IS MANDATORY

31. To insure independence and impartiality, an independent, fair and impartial Public Grand Jury to be Voir Dire by Complainants is mandated.

32. Moreover, as the U.S. is currently in a lawless state, Jury Trial protects the judicial government employees herein from retaliation crimes by other government employees.

V. DEMAND FOR INDEPENDENT IMPARTIAL JURY TRIAL

33. Demand is made for an Immediate, Urgent Habeas Corpus Jury Trial

¹ If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or If two or more persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured- They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death

² Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such person being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.

³ (1) A person who knowingly and willfully fails to report a case of known or suspected abuse, neglect, or exploitation of a vulnerable adult, or who knowingly and willfully prevents another person from doing so, commits a misdemeanor of the second degree, punishable as provided in s. 775.082 or s. 775.083.

⁴ **42 U.S. Code § 1983 - Civil action for deprivation of rights**

Every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory or the District of Columbia, subjects, or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suit in equity, or other proper proceeding for redress, except that in any action brought against a judicial officer for an act or omission taken in such officer's judicial capacity, injunctive relief shall not be granted unless a declaratory decree was violated or declaratory relief was unavailable. For the purposes of this section, any Act of Congress applicable exclusively to the District of Columbia shall be considered to be a statute of the District of Columbia.

10. We are far beyond the realm of terrorized and demand immediate rescue.

11. Demand is made for an Immediate, Urgent Habeas Corpus Jury Trial to rescue and release the hostages set forth on Exhibit B to be held immediately by this court of appeals or by issuance of a Writ Of Mandamus, Certirori or other Writ to immediate order a Habeas Corpus Jury Trial by the 1st circuit occur no later than Sept. 10, 2021.
