FINAL RECOMMENDATION

Pursuant to the direction of the Macomb County Circuit Court an investigation has been conducted addressing the question of permanent custody, child support, visitation, visitation abatement, health care expenses, and child care expenses of the minor child(ren) of the parties.

Based upon said investigation, it is the recommendation of the Office of the Friend of the Court that the best interests of the minor child(ren) will be served if ^{joint} legal custody of said minor child(ren) of the parties hereto be vested in the Plaintiff ^{and} Defendant, with physical custody to the Defendant.

It is further recommended that ^{specific} reasonable rights of visitation be granted to Plaintiff/Defendant provided the Plaintiff/Defendant shall receive a 50 percent retroactive abatement of the child support obligation after the minor child(ren) spends eight consecutive overnight periods with the Plaintiff/Defendant.

Said investigation would indicate that the Plaintiff's net weekly income amounts to \$ 404.66 and the Defendant's net weekly income amounts to \$ 1901.74. Therefore, based upon the

financial circumstances of the parties hereto, ~~agreement of the~~ ~~Plaintiff/Defendant~~, it would be the recommendation of the Office of the Friend of the Court that the

support to continue until each child attains the age of 18 years, or beyond if the child(ren) is/are regularly attending high school while residing on a full-time basis with the payee support or at an institution, but in no case after the child reaches 19 years and six months of age.

It is further recommended that the Plaintiff/~~XXXXXXXXXX~~ shall pay to the ~~XXXXXXXXXX~~/Defendant through the Macomb County friend of the Court for work or education related child care expenses the sum of \$ 13.00 per week.

It is further recommended that the Plaintiff/~~XXXXXXXXXX~~ shall maintain health care insurance coverage for the benefit of the minor child(ren) or obtain said coverage, if available at a reasonable cost.

It is further recommended that the Plaintiff pay 10 % of any uninsured health care expenses on the minor child(ren). The Defendant pay 82 % of any uninsured health care expenses on the minor child(ren).
