further, that the Plaintiff shall execute any and all documents necessary to convey over to Defendant said interest to said corporation.

IT IS FURTHER ORDERED AND ADJUDGED that any other stocks owed by the parties hereto jointly and/or individually shall be sold and the proceeds therefrom divided between the parties equally.

IT IS FURTHER ORDERED AND ADJUDGED that Defendant Husband shall pay to Plaintiff Wife as property settlement in this matter Ninety-Six Thousand (\$96,000.00) Dollars payable in full within eight (8) years from the date of this Judgment at the rate of One Thousand (\$1,000.00) Dollars per month.

IT IS FURTHER ORDERED AND ADJUDGED that Defendant Husband shall receive the parties' Land Contract interest in the property located at 30367 Gratiot, Roseville, Michigan, subject to any indebtedness thereon which he shall assume and discharge and from which he shall hold the Plaintiff harmless from. Furthermore, Plaintiff Wife shall maintain a lien on said property interest in the amount of One Hundred Thirty-Three Thousand One Hundred Fifty-Two (\$133,152.00) Dollars which amount represents the property settlement payment of Ninety-Six Thousand (\$96,000.00) Dollars and the first Thirty-Seven Thousand One Hundred Fifty-Two (\$37,152.00) Dollars of child support to be paid for CHRISTINA MARIE HANNAPORD. Upon full payment of said One Hundred Thirty-Three Thousand One Hundred Fifty-Two (\$133,152.00) Dollars payable at the rate of One Thousand Three Hundred Eighty-Seven (\$1,387.00) Dollars per month Plaintiff Wife shall discharge said lien.

IT IS FURTHER ORDERED AND ADJUDGED that each party shall be awarded their personal clothing and jewelry free and clear of any right, title or interest of the other herein, and
