COMPLAINT FOR SUPPORT AND RESTITUTION

A. That said defendant be required to answer this Complaint.

B. That upon final hearing, a Judgment of Support be granted, enforceable by the Macomb County Friend of the Court, as per MCL 552.452; MCL 722.3.

1. In the amount of \$125.00 per week (or guidelines) for the support of [REDACTED], minor child of the defendant.

C. That plaintiff may have such other further and different relief in the premises as shall be agreeable to equity and good conscience, justice and reason.

D. That defendant be responsible for all hospital, medical, dental, optical, and pharmaceutical expenses incurred on behalf of the child of the defendant.
